Course Description: This course provides an introduction to the interdisciplinary field of environmental studies and the Environmental Studies AOC at New College. The course provides an overview of natural and social systems relevant to environmental issues and explores current issues at local, national, and global scales. Perspectives from a range of disciplines will be brought to key topics such as sustainability, climate change, energy, population growth, urbanization, biodiversity and ecology, food security and natural resources, ethics, environmental policy, and other strategies for improving human-environment interactions. This is a required course for those seeking an Environmental Studies Area of Concentration. No prerequisites.

**Overview & Learning Objectives:** This course aims to describe and discuss current environmental issues. You will learn about the scientific process by examining the science behind environmental issues such as pollution, climate change, and the loss of biological diversity. There will be a focus on the interconnected nature of environmental issues and varying solutions will be presented and discussed. You will also learn how to access peerreviewed scientific articles and how to be a critical consumer of popular media. Class meetings will include lectures, guest presentations, discussions, and in-class activities.

Required Text: Environment and Society: A Reader, eds. C. Schlottmann, D. Jamieson, C. Jerolmack, A. Rademacher (NYU Press). It is available for purchase (new and used copies) at the campus bookstore. Have it by the beginning of week 2. I will also assign selections from the open-access textbook, <u>Environmental Biology</u>, ed. M. Fischer (Open Oregon). Download it or access it from the website. Other readings will be available on Canvas.

Anyone presenting symptoms is expected to follow the college-recommended protocol and should not attend F2F class but instead join us on Zoom. Symptoms of COVID-19 include but may not be limited to: fever, cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, new loss of taste or smell, diarrhea. If you tested positive, you may not return to class until you have met CDC and local health authority guidelines (at present, two negative tests taken at least 24 hours apart; but check the latest NCF recommendations). Students **MUST** also follow these common guidelines **in class**:

- **Wear a mask at all times** (surgical masks are better than cloth masks). While the CDC currently does not recommend N95 use for the general public, if you have one or an equivalent respirator, you are welcome to use it.
- Use Hand Sanitizer BEFORE AND AFTER entering the classroom.
- Clean your working space BEFORE and AFTER use. Cleaning supplies will be provided.
- Strive to maintain a safe 6-feet distance between each other
- I cannot admit more people inside the classroom than is allowed by the current COVID-19 guidelines. If necessary, rather than capping the class, I will ask students (except for first-years) to attend sessions remotely on a rolling basis.

Again, we all depend on each other for this class—and the whole term at New College—to follow through. Be respectful, considerate and kind to each other.
